If you have not received the Cargo Carrying Capacity Reduced Label or have an affected unit that was dealer traded, you can request a replacement label by contacting the Warranty Call Centre at 1-888-222-5546. Dealers will be required to provide a VIN at the time of ordering. Order item number 212340732 or the bulletin number N212340732. 

- Clean the mounting surface using isopropyl alcohol and dry with clean, lint free cloth. Receiving surface MUST be clean, dry and free of any contaminants.
- 6. Firmly hold the new label and peel protective liner from the back side, being careful not to touch or contaminate the adhesive with dirt or foreign matter.

Carefully align the top edge of the new label to the existing Tire and Loading Information label. Press firmly and smooth out entire label ensuring corners are fully adhered.

Dealer Responsibility

Dealers must take the steps necessary to ensure that the service update correction has been made to all involved vehicles in dealer inventory before selling or dealer-trading the vehicle, but no later than July 31, 2022.

Upon submitting an accepted/paid warranty transaction in the Global Warranty Management (GWM) system, the vehicle can be re-certified for sale within the CPOIS system, or once again be used in the CTP program.

This information is intended to assist dealers with the **PROMPT COMPLETION** of these vehicles. Service Update Bulletins are to be completed when the customer is in for a regularly scheduled visit.
