## ATTENTION: ALL DEALER PARTS \& SERVICE MANAGERS

Kia America, Inc. will be conducting a Voluntary Emissions Service Campaign to update the Engine Control Module (ECM) software programming on certain 2017-2018 MY Kia Forte vehicles equipped with the 2.0L Multi-Port Injection (MPI) engine that may have had a software update that turned off certain fuel system monitoring functions. While this issue has no effect on the drivability of the vehicle, nor does it release any air pollutants, the vehicle may fail a SMOG check and/or may not illuminate the Malfunction Indicator Light (MIL) for certain fuel system failures.

Attached are samples of the Vehicle Emissions Recall Proof of Correction Cards, under hood campaign labels, and information on how to access the list of affected vehicles on WEBDCS. NOTE: The Proof of Correction Cards and under the hood campaign labels are for California and S177 State dealers use only and can be ordered through the PDC.

The owner notification will be mailed on October 26, 2021.

Please start performing the repairs on any of the affected vehicles currently in your inventory prior to selling the vehicle to a retail customer.

## For California Dealers ONLY

- The State of California has implemented the Registration Renew/Recall Tie-In Program that requires the completion of Emission Recalls prior to vehicle registration renewal.
- Be sure to provide a filled-out Emissions Recall Proof of Correction Card to each owner upon completion of the campaign for owner use as proof of completion during registration renewal. Instructions for filling out this card can be found in the TSB. It is also required to affix a campaign completion sticker under the hood of the vehicle.

For Connecticut, Delaware, Maine, Maryland, Massachusetts, New Jersey, New York, Oregon, Pennsylvania, Rhode Island, Vermont, and Washington dealers ONLY:

- The above-named states require that a filled-out Emissions Recall Proof of Correction Card be provided to each owner for use, if requested, at vehicle registration renewal. Instructions for filling out this card can be found in the TSB. It is also required to affix a campaign completion sticker under the hood of the vehicle.

Please make certain the appropriate personnel in your dealership are familiar with the details of this campaign to ensure proper responses to customer inquiries and requests to have the campaign performed on their vehicles.
