Re:	Update to battery replacement parts: 19-21MY Ascent

Effective today, the recommended replacement battery for the 19-21 MY Ascent models is changing from the **SOA821B200 Flooded Battery** to the **SOA821B600 Enhanced Flooded Battery (EFB)**. This update will be reflected in the Battery Quick Reference Chart shortly. The battery Quick Reference Chart is available on SNET in Parts Operation > Parts Quick Reference Guide, by selecting <u>Batteries</u> in the Quick Reference Charts area.

While the **SOA821B200 Flooded Battery** is still being used as a replacement part in several models as indicated on the quick reference chart, the **SOA821B600 Enhanced Flooded Battery** (**EFB**) is now listed as the replacement part for 2019-2021 Ascent models. The purpose of this communication is to provide instructions and coding information to follow when replacing a SOA821**B200** flooded battery with a SOA821**B600** enhanced flooded battery (EFB) in one of the above Ascent models.

The information below outlines some potential scenarios retailers may encounter and how to address them. Each scenario can be found on the chart at the end of this document for a detailed breakdown of warranty coverage. A Technical Service Bulletin will be released outlining additional information regarding battery test procedures and warranty information. ### Warranty Replacement of an OE Battery or SOA821B200 using SOA821B600 – Scenario # 1

If a 2019-2021 Ascent vehicle with an original equipment (OE) battery or SOA821**B200** battery presents with a battery concern while the vehicle is within the 3/36 New Car Basic Warranty, the battery should be tested as outlined in the Claims Policies & Procedures Manual. If the battery test provides a result indicating a battery replacement is required, a SOA821**B600** should be installed. The retailer should submit a warranty claim, include the failed battery test code, claim the SOA821**B600** part number, and use the coding below. The SOA821**B600** comes with a 12 month/unlimited mileage parts warranty or the remainder of the 3/36 New Car Basic Warranty, whichever provides the greater coverage.

## Parts Warranty Replacement of SOA821B200 using SOA821B600 – Scenario # 2

In the instance where a SOA821**B200** in a 2019-2021 Ascent vehicle fails within the 30-month warranty period, a SOA821**B600** should be installed. The retailer should submit a parts warranty claim, claiming the SOA821**B600** part number and use the coding below. This will provide payment for the new SOA821**B600** installed and the associated labor hours. The SOA821**B600** comes with a 12 month/unlimited mileage parts warranty.

## Parts Warranty Replacement of Pro-rated SOA821B200 using SOA821B600 – Scenario # 3

In the instance where a SOA821**B200** in a 2019-2021 Ascent vehicle fails within the battery proration period (31-85 months), a SOA821**B600** should be installed. The retailer should submit a parts warranty claim, claiming the SOA821**B600** part number and use the coding below. This will provide payment for the new SOA821**B600** installed in the vehicle, and the customer will be responsible for paying the labor hours. SOA821**B600** will come with a 12 month/unlimited mileage parts warranty.

## Replacement of SOA821B600 using SOA821B600 – Scenario # 4

In the instance where a SOA821**B600** has previously been replaced in a 2019-2021 Ascent vehicle, and the replacement battery fails, the replacement will be covered either by the remainder of the 3/36 New Car Basic Warranty or by the 12 month/unlimited mile parts warranty period. In either case, a <u>new</u> SOA821**B600** should be installed. If the SOA821**B600** fails within the 3 year/36 mile new car basic warranty, the retailer should submit a warranty claim using the coding below, and part SOA821**B600** should be entered on the claim. If the SOA821**B600** fails within the 12 month parts warranty, the retailer should submit a parts warranty claim using the coding below and part SOA821**B600** should be entered on the claim.

## **Customer Pay Battery Replacement**

In the instance of a customer pay battery replacement, while the recommended repair is replacement of the battery with a SOA821**B600**, the customer does have the option of having a SOA821**B200** installed in their vehicle.

**NOTE:** Service procedures for battery replacement remain unchanged. Always refer to STIS for any applicable service information and to review the full requirements of the repair being performed. The STIS contains information critical to performing an effective repair the first time, every time. This includes important SAFETY precautions, proper inspection criteria, necessary special tools, required processes and related one-time-use parts needed for a complete and lasting repair.
