DESCRIPTION

Some vehicles may exhibit rust (1) on the liftgate around the border of the rear mount camera (2) and/or the liftgate opener switch (3). Repair the rust and install a pad to prevent future rust.

NOTE: This service bulletin is only applicable if the rust started from the marked area (1) around the holes. If rust occurs on other areas, this service bulletin is not applicable.

Customers having this concern should have their vehicle repaired using the following repair procedure.

REPAIR PROCEDURE

1. Verify customer concern.

2. Repair the affected area of the liftgate by ordinary paint rust damage repair procedure.

NOTE: Repair affected area(s) only. There is no need to repaint the whole liftgate.

3. To prevent direct interference of the rear mount camera and liftgate opener switch mount bases with the liftgate paint surface, attach a protector film (DBY0-62-864) to the liftgate.

NOTE:

- Degrease the liftgate where the protector film is attached.
- The protector film (A) must not cover the installation holes for the rear mount camera (B) and liftgate opener switch (C). To attach the protector film in the correct position, first align three edges (marked with 1 - 3 in figure) of the protector film with three edges (marked with 1 - 3 in figure) of the installation holes, and then attach the whole protector film without leaving air bubbles.
