 - MAZDA2: FORWARD SENSING CAMERA (FSC) REMOVAL/INSTALLATION
 - MAZDA3: FORWARD SENSING CAMERA (FSC) REMOVAL/INSTALLATION
 - MAZDA6: FORWARD SENSING CAMERA (FSC) REMOVAL/INSTALLATION
- 3. Verify the repair.
