AIR CONDITIONING COMPRESSOR NOT ACTIVATED BY IHKA (EV)

This Service Information Bulletin (Revision 1) replaces SI B64 07 21 dated August 2021.

What's New (Specific text highlighted):

ISTA SW version that contains the software

SITUATION

Only warm air comes out of the vents despite the air conditioning being switched on. The status indicator LED on the air conditioning control panel (IHKA) lights up green. No related fault codes are stored in the IHKA.

CAUSE

Faulty parameters in the IHKA control unit.

CORRECTION

Diagnose the air conditioning system. If no related faults are found, program the vehicle with ISTA **4.31.3** (released September 23, 2021) to I-Level S15A-21-07-540 or higher. Replacement of the IHKA control panel is not necessary.

PROCEDURE

Determine the vehicle's current I-level by either using AIR or the ISPA NEXT application.

Perform a vehicle test and check for any related IHKA fault codes.

If no relevant faults are stored, program the vehicle with ISTA **4.31.3** to Integration Level **S15A-21-07-540** or higher.

Note that ISTA will automatically reprogram and code all programmable control modules that do not have the latest software.

Always connect a BMW-approved battery charger/power supply (<u>SI B04 23 10</u>) when performing programming.

For information on programming and coding with ISTA, refer to DealerSpeed / TIS / Technical Documentation / Diagnostics and Programming / Programming Documentation.

PARTS INFORMATION

Replacement of the IHKA control panel is not necessary.

WARRANTY INFORMATION

During this workshop visit, the affected vehicle may show one or more programming and encoding Technical Campaign repairs open. If so, the programming and encoding procedure may only be invoiced one time.

Select one of these open Technical Campaigns to perform and submit for updating the vehicle's software to the required I-level or higher.

If you are using a Main labor code for another repair, use the Plus code labor operation 00 00 556 instead of 00 00 006.

Programming and Encoding - Vehicle Control Units (RO and Claim Comments Required)

This procedure automatically reprograms and encodes any vehicle control modules that do not have the latest software I-level.

If one or more control modules fail during the reprogramming procedure, claim the required consequential repair work procedures to address this issue (including performing the IRAP Control Unit Recovery first as required, refer to the SIB in AIR) under the Defect Code in this bulletin with the labor operations in AIR that apply.

Please explain the additional work procedures that were performed (The why and the what) on the repair order and in the claim comments.

For covered repairs that address control module failures that occurred prior to performing this reprogramming procedure, claim this work with the Defect Code and labor operations (including diagnosis) in AIR that apply.

Based on which one applies to your center, please refer to <u>SI B01 01 20</u> or <u>B01 07 20</u> for claiming your diagnosis work time, job/repair work time (WT), RO/Claim WT and/or repair explanation procedures, unless otherwise required by State law.

Other Repairs

If other eligible and covered work is performed as a result of performing the ISTA diagnostics and related test plans, claim this work with the applicable Defect Code and the labor operations listed in AIR (including
