Please perform the procedure outlined in this Service Information on all affected vehicles before customer delivery. In the event the customer has already taken delivery of the vehicle, please perform the procedure the next time the vehicle is in the shop.

### **SITUATION**

Due to an unfavorable operating point primarily in the low-end torque range, the fuel vapor scavenging that takes place in that range may result in incorrect detection of a mixture that is too rich. As a result, an incorrect mixture adaptation value is stored.

#### **CAUSE**

A software error in the DME (Digital Motor Electronics).

### CORRECTION

Program the vehicle using ISTA 4.32.2x or higher (released early November 2021)

Program the vehicle using ISTA 4.32.2x or higher.
