

DESCRIPTION

Some customers may complain about a whistling noise heard from the top of the A-pillar area and/or the top of windshield area when driving at highway speeds.



When driving under the following conditions, a negative pressure is generated on the doors and the windshield pulling them outward and resulting in weatherstrip vibration.

- The vehicle is exposed to a side wind while driving at highway speeds.
- The vehicle is exposed to a strong side wind while driving at a speed slightly higher than highway speed.

Customers having this concern should have their vehicle repaired using the following repair procedure.


REPAIR PROCEDURE

NOTE: Attach rubber pads to the doors and the top of the windshield. Depending on the repair history of the vehicle, repair one or both of them.

DOOR REPAIR:

- 1. Verify the customer's concern.
- 2. Remove the upper-side front door weatherstrip.

NOTE: Use a fastener remover and remove the fasteners in the order shown below.



NOTE: Do not remove the fastener in the corner (indicated by the red circle above/right, p/n KB7W-5*-762), as it could break.

3. Remove any grease or dust from the surface where the weatherstrip was attached.


4. Attach the pads next to the front doors hem:

- a) Attach the longest pad (t2.4 x w4 x L1000mm) as shown below.
- Start attaching from the front side, 120mm away from the sash molding tip (1).


- While attaching the pad, it may wander, so initially attach the pad lightly and after the whole length of the pad is positioned, press it down against the hem for a firm bonding (2).





b) Attach pad (t1.9 x w4 x L300) onto the long pad installed in step a above.

- Use fastener No. 4 position (1) as a reference for the attachment starting point.

- While attaching the pad, it may wander, so initially attach the pad lightly and after the pad is positioned, press it for final bonding (2).


5. Reinstall the weatherstrip with the fasteners (BC1D-58-762). **NOTE:** If the fasteners are damaged, replace them with new ones.

6. Repeat steps 2 - 5 for the other side front door.

WINDSHIELD REPAIR:

1. Using a plastic tool (1) with a flat tip, lift the lip (3) of the weatherstrip, then insert the pad (2) under the lip all the way between roof moldings.

CAUTION: DO NOT USE a metal tool. It may damage the paint and result in rust.

2. Ensure that the lip fits properly with the roof panel.



3. Verify the whistling noise is gone.
