#### \*\*\*\*\* Campaign Summary \*\*\*\*\*

Nissan is issuing a Voluntary Emissions Recall Campaign on specific MY2013-2017 NV200 and MY2014-2017 NYC Taxi vehicles identified in Service Comm and DBS National Service History to reprogram the Engine Control Module (ECM).

Nissan has determined that the software in the Engine Control Module (ECM) may not be calibrated properly. The On Board Diagnostic (OBD) monitor may not detect a manifold catalyst below the efficiency threshold in all circumstances as required by regulation.

#### \*\*\*\*\* What Dealers Should Do\*\*\*\*\*

- Verify if vehicles are affected by this Voluntary Emissions Recall using Service Comm or DBS National Service history – Open Campaign I.D. <u>R21B3</u>
  - New vehicles in dealer inventory can also be identified using DBS (Sales-> Vehicle Inventory, and filter by Open Campaign).
    - Refer to NPSB 15-460 for additional information
  - Please continue to check newly arriving inventory for campaign applicability.
- 2. Dealers should use **NTB21-105** to remedy any vehicles subject to this campaign.
- 3. Once remedied, dealers should submit the claim, using the claims coding provided, and release the vehicle.

#### \*\*\*\*\* Dealer Responsibility \*\*\*\*\*

It is the dealer's responsibility to check Service Comm or DBS National Service History using the appropriate Campaign I.D. for the campaign status on each vehicle falling within the range of this voluntary emissions recall campaign, which for any reason enters the service department. #### Q. What is the reason for this emissions recall?

A. Nissan has determined that the software in the Engine Control Module (ECM) may not be calibrated properly.

#### Q. What is the possible effect of the condition?

A. The On Board Diagnostic (OBD) monitor may not detect a manifold catalyst below the efficiency threshold in all circumstances as required by regulation.

#### Q. What will be the corrective action for this voluntary emissions recall campaign?

A. Dealers will reprogram the Engine Control Module (ECM).

#### Q. How long will the corrective action take?

A. This service, which is conducted at no charge to you for parts and labor, could take up to one (1) hour to complete. However, your Nissan dealer may require your vehicle for a longer period of time based upon their work schedule.

#### Q. When will vehicle owners be notified?

A. Nissan will begin notifying owners of all potentially affected vehicles in **December 2021** via U.S.
 Mail.

#### Q. Is my vehicle safe to drive?

A. If your vehicle is subject to this campaign, you will receive an Owner Notification letter from Nissan, which will provide instructions on how to remedy your vehicle. Affected owners are encouraged to have their vehicles repaired as soon as possible.

#### Q. Is there anything owners can do to mitigate this condition?

A. No.

#### Q. Are parts readily available?

A. The remedy is reprogramming, no other parts are required for this campaign.

#### Q. Is there any charge for this service?

A. No. The remedy will be performed for the customer free of charge for parts and labor.

#### Q. Will a rental vehicle be provided while the dealer is servicing the vehicle?

 Please consult your dealer for alternate transportation availability while your vehicle is being serviced. If the reprogramming cannot be performed successfully and a replacement Engine Control Module (ECM) needs to be ordered, rental is available upon customer request.

#### Q. Will I have to take my vehicle back to the selling dealer to have the service performed?

A. No, any authorized Nissan dealer is able to perform this emissions recall campaign.

For Consumer Affairs: Please inform us of the dealer where you would like to have the corrective action completed.

#### Q. I have lost confidence in the vehicle. Will Nissan replace or repurchase the vehicle?

A. The remedy will fully correct this condition. As the condition will be corrected, there is no basis for repurchasing or replacing your vehicle.

#### Q. What model year vehicles are involved?

A. Certain Model Year 2013-2017 Nissan NV200 vehicles manufactured from July 23, 2012 to October
 5, 2017 at the Cuernavaca, Mexico plant and Certain Model Year 2014-2017 Nissan NYC Taxi vehicles
 manufactured from April 3, 2013 to March 24, 2017 at the Cuernavaca, Mexico plant are affected.

#### Q. Are you experiencing this condition on any other Nissan (or INFINITI) models?

A. Yes. Certain Model Year 2018 NV200 (M20) vehicles manufactured in Cuernavaca, Mexico between
 October 3, 2017 and August 8, 2018 are also affected and are the subject of a different campaign
 ID (PM947).
