**Customer Complaint/Technician Observation:** Owner complains the right rear parking lamp does not illuminate. Technician observed that the lamp is out, no DTC's present.

**Repair Procedure:** Inspect the side marker park lamp connector for power, lamps on. If no power, inspect the L17 circuit at XY708A inline connector for any damaged and or pushed out terminals. If no concerns, trace the L17 circuit back to XY675A pin 3 as needed, see Fig 1, 2, 3.

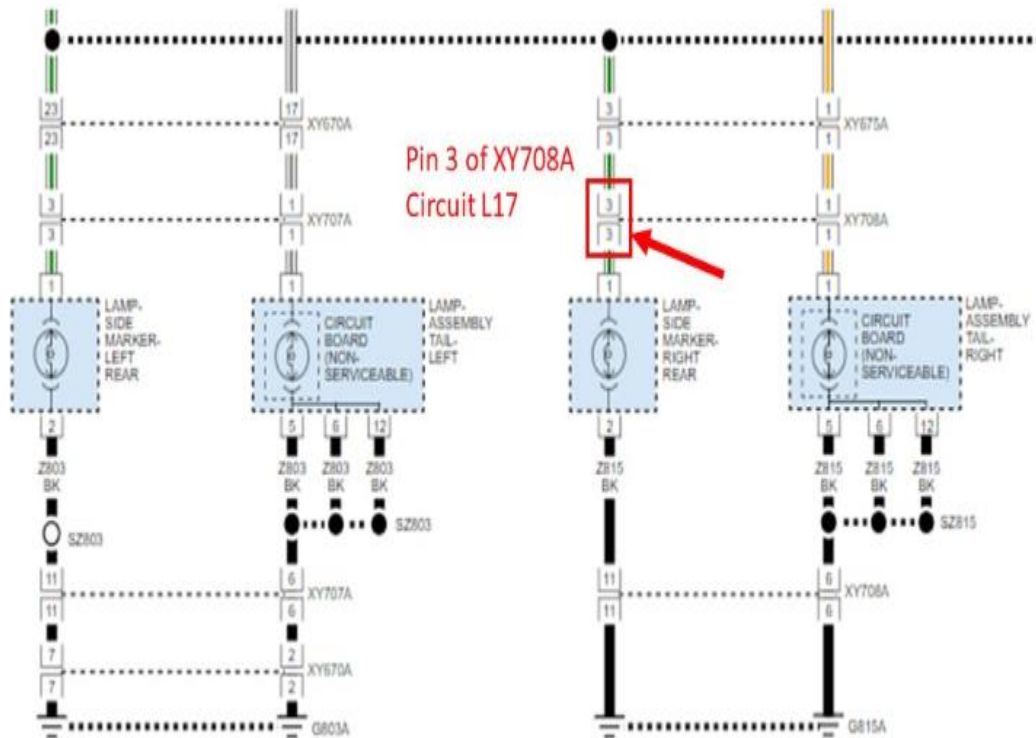
