



CAUSE

Software in the instrument cluster MID (Kombi MID).

CORRECTION

Program the vehicle.

PROCEDURE

- 1. Confirm that the vehicle is equipped with the Kombi identified in the Situation section above.
- 2. Determine the vehicle's current I-level by either using AIR or the ISPA NEXT application. If needed, use the latest ISTA to work through test modules.
- 3. Is the current vehicle integration level:

G01 G02 G12 G30 G32	Greater than or equal to S15A-19-11-520 and lower than S15A-21-07-550

YES: Proceed to Step 4

NO: Further diagnosis with ISTA is needed

4. Program the vehicle using ISTA 4.31.3x or higher (released September 2021).

Note that ISTA will automatically reprogram and code all programmable control modules that do not have the latest software.

Always connect a BMW-approved battery charger/power supply (SI B04 23 10).
