Miscibility: **All engine oils approved by Porsche can be mixed provided they are of the same Porsche oil specification.** This means that it is not necessary to flush the engine when the oil is changed if another type of oil is used. However, since each oil brand has a specially matched composition, an oil of the same brand and grade should be used where possible when topping up between oil change intervals.
