Prior to launching the VAS Diagnostic Tester and starting an update, ensure the following conditions are met;

- √ The ODIS software is completely up to date.
 - Refer to the "Alerts" section on ServiceNet home page for the current ODIS version.
- √ The battery charger is connected to the vehicle battery and remains connected for the duration of the software update.
 - Battery voltage must remain above 12.5 volts for the duration of the software update. Failure to

- √ The screen saver and power saving settings are off.
