SUBJECT: ENGINE OIL FILLER CAP REPLACEMENT (SC224)

This bulletin provides information to replace the oil filler cap on some 2022MY Seltos (SP2) and Soul (SK3) vehicles produced in the date ranges listed below, which may have an oil filler cap with the incorrect viscosity description ("SAE 5W-20", correct description: "SAE OW 20"). Follow the procedure outlined in this publication to replace the oil filler cap with the correct part. Before conducting the procedure, verify that the vehicle is included in the list of affected VINs.



ENGINE OIL FILLER CAP REPLACEMENT (SC224)

Replacement Procedure:

1. Open the hood and remove the existing oil filler cap (A).

<u>Note</u>: The incorrect viscosity is printed on the cap (SAE 5W-20).



2. Replace with the <u>new</u> oil filler cap (B) with the <u>correct</u> viscosity printed (SAE OW 20).

ATTENTION: THE PROOF OF CORRECTION CARD AND CAMPAIGN COMPLETION STICKER ARE RESTRICTED ONLY TO DEALERS IN THE FOLLOWING STATES:

California, Connecticut, District of Columbia, Maine, Maryland, Massachusetts, New Jersey, New York, Oregon, Pennsylvania, Rhode Island, Vermont, and Washington. See Parts Information below to order the Proof of Correction Card and Campaign Completion Label from the PDC.

VEHICLE EMISSION RECALL - PROOF OF CORRECTION CARD

A Vehicle Emission Recall - Proof of Correction card must be filled out for all vehicles registered in California, Connecticut, Maine, Maryland, Massachusetts, New Jersey, Oregon, Pennsylvania, Rhode Island, Vermont, Washington, New York and Delaware. Residents of these states, who own an affected vehicle, will be required to possess a Vehicle Emission Recall - Proof of Correction card as evidence of voluntary service campaign completion, when they apply for vehicle registration renewal.

WHAT TO DO WITH THE CARD:

The Vehicle Emission Recall - Proof of Correction card <u>must be completed by the Dealership's Service Manager using a permanent ink pen</u>. A fine point pen is recommended. When filling in the information, copy the information directly from the vehicle, not the repair order. **ALL INFORMATION MUST BE PRINTED AND NEAT.**

NOTE: DO NOT COMPLETE THE CARD UNLESS THE SERVICE CAMPAIGN WORK IS COMPLETED.

The copy of the card shown below indicates the areas to be filled in. Each area must be filled in. The completed card should be given to the owner of the vehicle upon completion of the Campaign and placement of the Campaign Completion Label outlined below.



FILLING OUT AND APPLYING THE CAMPAIGN COMPLETION LABEL (CA and S.177 STATES ONLY):

The dealer must fill in the Dealer Code and Date information fields on the Campaign Completion Label. Once complete, affix the campaign completion label under the hood of the vehicle, as shown below.

CA and S.177 States Only: Apply <u>SC224</u> Campaign Completion Label onto the body in the area next to the shock tower, as shown. NOTE: Be sure to clean the mounting surface to ensure proper label adhesion.
