Cause	GM Engineering is attempting to determine the root cause of the above condition. Engineering has a need to gather information on vehicles PRIOR to repair that may exhibit this condition. As a result, this information will be used to "root cause" the customer's concern and develop/validate a field fix.	

Correction

If you encounter a vehicle with the above concern, perform the following steps and contact the engineer listed below with your findings.

- Record all DTCs.
- Record if the airbag lamp is steady "on" or is it "flashing" in the driver information center (DIC). 2.
- Record if passenger airbag "OFF" status indicator telltale, located in the center console right side of the shifter, is illuminated when someone is seated in the front passenger seat.
- Record if seat belt indicator telltale is illuminated when the passenger seat is not occupied and not buckled, and the driver seat is occupied and belt is buckled.
- Replace the Passenger Presence Module (qty 1), Occupant Classification System Sensors (qty 2) (use a paint marker and identify "front" and "rear" on the sensors) and the Inflatable Restraint Sensing and Diagnostic Module (qty1) ("plug and play" no programming needed) according to the steps identified in Document ID's listed above.
