Service Procedure

- 1. Raise the vehicle on a hoist. Refer to Lifting and Jacking in SI.
- Partially remove the left and right rear wheelhouse liners, it is only necessary to remove the 4 front fasteners and the air deflector. Carefully fold the wheelhouse liners allowing access to the work area. Refer to Rear Wheelhouse Liner Replacement in SI.





3. Locate the skip in the sealer on the left and right-side inner wheelhouse. See the graphic for the area to be sealed.

- 4. Locate the out of position seam sealer between the outer wheel well and the outer panel hem flange. See the above graphics for the sealing location. The actual sealing area is on the inside of this area.
- 5. Clean the sealing areas with a general-purpose adhesive remover.

- 6. Using Kent Automotive High-Tech Seam Sealer-Clear, seal the left and right wheelhouse joints and left side hem flange area identified in the graphics above. Ensure the complete area is sealed. Smooth the sealer with a small brush to ensure coverage. Note that only the left side hem flange requires sealing.
- 7. To avoid contaminating the wheelhouse liner material, allow the seam sealer to cure per the manufacturer's instructions.
- 8. Reinstall the wheelhouse liners and fasteners as required. Refer to Rear Wheelhouse Liner Replacement in SI.

Dealer Responsibility

All new, used, GM Certified Used, courtesy transportation vehicles, dealer shuttle vehicles, etc. in dealers' possession and subject to this program <u>must</u> be held and inspected/repaired per the service procedure of this bulletin <u>before</u> customers take possession of these vehicles. Involved vehicles must be held and not delivered to customers, dealer-traded, released to auction, used for demonstration, or any other purpose.

All GM Certified Used vehicles currently in the dealers' inventory within the Certified Pre-Owned Inventory System (CPOIS) will be de-certified and must be held and remedied per the service procedure in this bulletin. Upon submitting an accepted/paid warranty transaction in the Global Warranty Management (GWM) system, the vehicle can be re-certified for sale within the CPOIS system, or once again be used in the CTP program.

Dealers are to service all vehicles subject to this program at no charge to customers, regardless of mileage, age of vehicle, or ownership, through May 31, 2024. Customers who have recently purchased vehicles sold from your vehicle inventory, and for which there is no customer information indicated on the involved vehicle listing, are to be contacted by the dealer. Arrangements are to be made to make the required correction according to the instructions contained in this bulletin. A copy of the customer letter is provided in this bulletin for your use in contacting customers. Program follow-up cards should not be used for this purpose, since the customer may not as yet have received the notification letter.

In summary, whenever a vehicle subject to this program enters your vehicle inventory or is in your facility for service through May 31, 2024, you must take the steps necessary to be sure the program correction has been made before selling or releasing the vehicle.

Dealer Reports - For USA
