- If these do not match, check for other charge air system leaks (if no other charge air system leaks are present). Replace the post intercooler charge air pipe.
- The charge air pipe may cause this complaint on vehicles produced before October 14th 2021.
- Possible accumulation of material inside charge air pipe with part number 80A.145.673.\* (Figure 1).
