Symptom/Vehicle Issue: Driver Side Mirror Surround View Camera Inoperative

Customer Complaint/Technician Observation: Owner complains the camera image from the driver side mirror is not displaying the driver side camera image. The technician observed the vehicle has set one or more of DTC's: B23C6-92 Left-Camera Performance or Incorrect Operation, B23C6-1C Left Camera-Circuit Voltage Out of Range, U0266-00 Lost communication With Left Camera; all other cameras supporting 360-degree camera surround view(s) are operating.

Repair Procedure: Gain access to the Camera Video Processing Module (CVPM) and check all the camera connections to ensure all connections are secure. If no change, test to validate the driver camera functionality by swapping the driver camera (Tan) connection at the CVPM to the working (Brown) connector location for the passenger image. If no image, start at the nearest camera connection at the driver mirror, bypass sections of the harness to locate the area of a potential wiring concern. In the below example, the door harness was the area of concern Fig 1, 2, 3.




