### SUBJECT:

Flash: Powertrain Diagnostic and System Improvements

### **OVERVIEW:**

This bulletin involves reprogramming the Powertrain Control Module (PCM) with the latest available software.

### **MODELS:**

2018 (LD) Dodge Charger 2018 (LX) Chrysler 300

NOTE: This bulletin applies to vehicles within the following markets/countries: North America, LATAM, APAC and EMEA.

NOTE: This bulletin applies to vehicles equipped with a 6.4L V8 SRT Hemi MDS Engine (Sales Code ESG).

# SYMPTOM/CONDITION:

Customers may experience a Malfunction Indicator Lamp (MIL) illumination and Adaptive Cruise Control inoperative. Upon further investigation the technician may find that the following Diagnostic Trouble Code (DTC) has been set:

P0573 - Brake Switch 1 Stuck Off.

Other software enhancements include:

\*\*Engine REV stationary exhaust noise restrictions.\*\*

### **DIAGNOSIS:**

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in DealerCONNECT/Service Library, verify all related systems are functioning as designed. If DTCs or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If the customer describes the symptom/condition listed above or if the technician finds the DTC, perform the Repair Procedure.

### REPAIR PROCEDURE:

NOTE: Install a battery charger to ensure battery voltage does not drop below 13.2 volts. Do not allow the charging voltage to climb above 13.5 volts during the flash process.

NOTE: If this flash process is interrupted/aborted, the flash should be restarted.

- 1. Reprogram the PCM with the latest available software. Detailed instructions for flashing control modules using the wiTECH Diagnostic Application are available by selecting the application's "HELP" tab.
- 2. Clear any DTCs that may have been set in any modules due to reprogramming. The wiTECH application will automatically present all DTCs after the flash and allow them to be cleared.

- When utilizing this failure code the 3C's (customer's concern, cause and correction) must be provided for processing Technical Service Bulletin flash/reprogramming conditions.
