Volkswagen has determined that a small number Transmission Control Modules (TCMs) contained an incorrect software version, either due to an error encountered during application of the Approved Emissions Modification (AEM) or due to a service parts error. The emissions impact is undetermined for vehicles affected by this action.

Service Consultant

Repair:

- REPAIR AVAILABLE November 29, 2022 / Update the TCM software
- See ELSA/ServiceNet for complete repair & claiming instructions
- Check both the daily Campaign Open Inventory report <u>and</u> OMD for affected vehicles in inventory. Verify OPEN status in ELSA <u>on the day of repair</u>.
- Repair every affected inventory vehicle before delivery to consumers.

<u>Canada:</u> Loaner/rental coverage cannot be claimed under this action. Please refer to the Volkswagen Service Loaner Program to determine loaner eligibility.

### Requirements for Emissions Campaigns Having Customer Notification (CALIFORNIA ONLY)

The California Air Resources Board and the Department of Motor Vehicles (DMV) require emissions-related campaigns to be completed prior to vehicle registration renewal. When campaign work is done you must provide the owner with a signed "Vehicle Emission Recall – Proof of Correction" certificate (RC EMISCAVWAU). Certificates can be ordered at no cost online via the Compliance Label Ordering portal.

<u>Please note:</u> This action is fully independent of the approved diesel modification recall on TDI vehicles. For owner convenience, this action can be performed at the same time as other service work, but can also be done independent of the diesel modification. Owners do not need to receive the diesel modification in order to receive this repair.
