SUBJECT:

Hood Ajar Switch Inoperative

OVERVIEW:

This bulletin involves replacing the hood ajar switch.

MODELS:

2022

(WL) Jeep Grand Cherokee

- NOTE: This bulletin applies to vehicles within the following markets/countries: North America, India/Asia Pacific, Middle East/Africa and South America.
- NOTE: This bulletin applies to vehicles built on or after May 27, 2022 (MDH 0527XX) and built on or before July 06, 2022 (MDH 0706XX).

SYMPTOM/CONDITION:

The customer may experience a Malfunction Indicator Lamp (MIL) illumination. Upon further investigation the technician may find the following Diagnostic Trouble Code (DTC):

• P152E - Engine Hood Switch 2 Circuit High.

Customers may also experience:

- Start/Stop system warning light.
- Start/Stop inoperable.
- Remote start inoperable.

DIAGNOSIS:

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in DealerCONNECT/Service Library, verify all related systems are functioning as designed. If DTCs or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If a customer's VIN is listed in VIP or your RSU VIN list, perform the repair. This RSU is only for vehicles on the RSU VIN list.

- 2. Clear all DTCs that may have been set in any module during this repair procedure.
