OVERVIEW:

This bulletin involves replacing the hybrid battery charging cables.

NOTE: This bulletin applies to vehicles built on or before April 15, 2022 (MDH 0415XX)

equipped with a 3.6L V6 PHEV Hybrid Engine (Sales Code EH3).

SYMPTOM/CONDITION:

Customers may experience the following:

Charge cable fails to charge with a message in the cluster "Check External Charging System".

PARTS REQUIRED:

DIAGNOSIS:

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in DealerCONNECT/Service Library, verify all related systems are functioning as designed. If DTCs or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If a customer's VIN is listed in VIP or your RSU VIN list, perform the Repair Procedure. **This RSU** only applies to vehicles on the RSU VIN list.
