#### TAILGATE SPORADICALLY FAILS TO OPEN

E-Series	Model Description	Production Date
120	iX Sports Activity Vehicle	Oct. 28 – Nov. 10, 2022

### **SITUATION**

The tailgate sporadically fails to open when signaled via the interior button (driver's door panel) or the key fob. It will unlatch but does not open any further.

# **CAUSE**

A software error in the HKFM (Tailgate function module).

# **CORRECTION**

Program the vehicle using ISTA version 4.40.1x (1020-23-03-500) estimated release 02/2023.

# **PROCEDURE**

- 1. Determine what is the vehicle's current I-level by either using AIR or the Key Reader/ISPA NEXT/AWP (Aftersales Workplace) applications.
  - If the vehicle's I-level is below I020-23-03-500, continue to step 2
  - Otherwise, if the I-level is greater than or equal to I-level 23-03-500, continue diagnosis using ISTA
- 2. Program the vehicle using ISTA version 4.40.1x (estimated release late Feb. 2023 pending verification) or higher for target I-level I020-23-03-500.

Note: ISTA will automatically reprogram and code all programmable control modules that do not have the latest software.

Always connect a BMW-approved battery charger/power supply (SI B04 08 09) when performing programming.

### PARTS INFORMATION

Parts are not required.

#### **CLAIM INFORMATION**

During this workshop visit, the affected vehicle may show one or more programming and encoding Technical Campaign repairs open, the programming and encoding procedure may only be invoiced one time.

Select one of these open Technical Campaigns to perform and submit for updating the vehicle's software to the required I-level or higher.

Please be sure to perform any additional before and/or after work (including attaching labels) as required by the open campaigns on the vehicle. Close any remaining open programming and encoding Campaign repairs as outlined in the corresponding Service Information Bulletin.

Work time labor operation codes 51 00 001 and 00 58 500 are not considered a Main labor operations.

#### Programming and Encoding - Vehicle Control Units (RO and Claim Comments Required)

This procedure automatically reprograms and encodes any vehicle control modules that do not have the latest software I-level.

If one or more control modules fail during the reprogramming procedure, claim the required consequential repair work procedures to address this issue (including performing the IRAP Control Unit Recovery first as required, refer to the SIB in AIR) under the Defect Code in this bulletin with the labor operations in AIR that apply.

For covered repairs that address control module failures that occurred prior to performing this reprogramming procedure, claim this work with the Defect Code and labor operations (including the diagnosis that applies\*) in AIR that apply.
