

New extended warranty coverage options for towing were made available beginning January 21, 2023 for our **Saf-T-Liner C2 and Saf-T-Liner eC2 products**. The new options provide higher cost caps for incurred, approved towing that occurs within the coverage parameters. These extended warranty options cover reasonable towing costs to the nearest authorized service facility due to warrantable failure, the powertrain component is either inoperable, vehicle cannot be safely operated, or continued operation would cause further damage to the product.
