Condition	Some customers may comment on brake squeal noise at low mileage and can be particularly noisy at low speeds.	
Cause	This condition may be caused by the brake pads equipped on the vehicle being susceptible to producing brake squeal.	
Correction	If the brake squeal noise is confirmed to be coming from the front brake pads, replace the front brake pads with a new design brake pad that aims to prevent brake squeal.	

Service Procedure

Important: Service agents must comply with all International, Federal, State, Provincial, and/or Local laws applicable to the activities it performs under this bulletin, including but not limited to handling, deploying, preparing, classifying, packaging, marking, labeling, and shipping dangerous goods. In the event of a conflict between the procedures set forth in this bulletin and the laws that apply to your dealership, you must follow those applicable laws.

Important: The front brake pads should **ONLY** be replaced with P/N 42790921 when brake squeal is heard. If vehicle brake pads are replaced with P/N 84685662, it will not permanently correct this issue. Refer to *Front Disc Brake Pads Replacement* in SI.
