Miscibility:

All engine oils approved by Porsche can be mixed provided they are of the same Porsche oil specification. This means that it is not necessary to flush the engine when the oil is changed if another type of oil is used. However, since each oil brand has a specially matched composition, an oil of the same brand and grade should be used if possible when topping up between oil change intervals.
