Some customers may comment that when the vehicle is cold or has sat for seve a noise can be heard from the rear of the vehicle when making one or two turns Some customers may also comment that the noise goes away after the vehicle warmed up.			
Cause	This condition may be caused by slip/stick of the posi-traction clutch plates.		
Correction	<ul> <li>if the moan noise is validated, perform the following Service Procedure. Service Procedure Note: Ensure the fluid is at operating temperature before draining by driving the vehicle.</li> <li>1. Replace the rear differential axle lubricant.</li> <li>2. Bring the gear lubricant again up to operating temperature.</li> <li>3. Perform multiple figure eight or lock steer turning maneuvers to work the gear lubricant into the clutch pack.</li> <li>4. Allow the vehicle to cool (back to ambient temperature) and re-evaluate for clutch moan.</li> <li>⇒ If the moan is still present, repeat steps 1-4.</li> <li>The above sequence may need to be repeated two to three times to reduce/eliminate the noise. Parts Information Correct lubricant is critical for proper operation. Refer to Specifications in SI.</li> </ul>
