
- 1. Save all VIN plates and/or B-Pillar Safety Certification labels removed from the vehicle until the new VIN plate or label arrives.

 - b. Enter the VIN into Quick VIN Order of the VIN-Specific Items tab of the Order form.
 - c. Select the desired label.

- d. When requested, enter the weight information from the original B-Pillar Safety Certification label. This information will be required to complete the web-based form.
- 3. The completed web-based form will be electronically routed to the Compliance Label Coordinator for approval.
 - a. The compliance Label Coordinator will take the necessary steps to fulfill the request.
 - b. Once the VIN plate and/or Safety Certification label is received from Audi AG, the Compliance Label Coordinator will provide the label to the dealership.
