REPAIR PROCEDURE:

- Perform front toe adjustment. Refer to the detailed service procedures available in DealerCONNECT> Service Library under: Service Info> 02 Front Suspension / Wheel Alignment / Standard Procedure> Front Wheel Alignment> Toe adjust.
- 2. Confirm steering wheel is centered.
