## **SITUATION**

After programming to I-level 23-03-5xx, the fault memory 0x022270 is stored in the mPAD (Medium Platform Automatic Driving) and cannot be deleted. A Check Control message "Driver assistance" is displayed in the central information display.

## **CAUSE**

Software error in the mPAD.

## **CORRECTION**

IRAP solution for the mPAD control unit.

### **PROCEDURE**

Determine the vehicle's current integration level (I-level) by either using AIR or the ISPA Next/AWP (Aftersales Workplace) applications.

### The complaint is resolved with I-level 23-03-545 (released April 12, 2023).

To address this issue, proceed as follows:

- 1. End the ISTA session.
- 2. Contact Technical support (TSARA) for an IRAP session, referencing SI B66 10 23.
- 3. Break the connection after IRAP is complete.
- 4. Perform a vehicle test.
- 5. Calculate and carry out a measures plan.
- 6. Then manually select a complete encoding.
- 7. Allow vehicle to go to sleep.
- 8. Reassess the vehicle.

## **CLAIM INFORMATION**

#### Vehicle Programming and Encoding

During this workshop visit, the affected vehicle may also show one or more programming and encoding Technical Campaign repairs open, the programming and encoding procedure may only be invoiced one time.

Select one of these open Technical Campaigns to perform, and submit for updating the vehicle to the required Ilevel or higher.

Please be sure to also perform any additional before and/or after work (including attaching labels) as required by the open campaigns on the vehicle. Close any other open programming and encoding Campaign repairs as outlined

### in the corresponding Service Information Bulletin.

Only when the above does not apply, the BMW software solution is then:

Work time labor operation codes 61 00 006 and 00 58 500 are not considered Main labor operations.

### Vehicle Programming and Encoding – Additional Work (RO and Claim Comments Required)

This procedure automatically reprograms and encodes any vehicle control modules that do not have the latest software llevel.

If one or more control modules fail during the reprogramming procedure, claim the required consequential repair work procedures to address this issue (including performing the IRAP Control Unit Recovery first as required, refer to the SIB in AIR) under the Defect Code in this bulletin with the labor operations in AIR that apply.

Please explain the additional work procedures that were performed (The why and the what) on the repair order and in the claim comments.

For covered repairs that address control module failures that occurred prior to performing this reprogramming procedure, claim this work with the Defect Code and labor operations (including the diagnosis that applies\*) in AIR that apply.
