#### **Concern Outline:**

On thirteen CX-90 vehicles, there is a possibility that certain bolts may not be tightened completely, allowing the bolts to become loose and come off during driving. The affected Mazda dealers with these 13 vehicles in dealer stock have been contacted directly. The list of VIN's and dealers with affected inventory are below.






# 3. Repair Procedure


- A) Lift the vehicle
- B) Inspect and Tighten the LH and RH Front Upper Control Arm Ball Joint Bolt to Steering Knuckle and ensure the ball joint is fully inserted into the Steering Knuckle
  a. Torque the Bolt to 42.5 N·m {4.3 kgf·m, 31.15 ft·lbf}



Replace the bolt and nut if they are missing.

C) Inspect and tighten the LH and RH Front ABS Wheel Sensor Bracket to the Steering Knuckle to 82in-lbf, or 9.5N-m. Inspect Bolt 5.




Note: If the bolt is missing, replace the missing bolt. Follow the WSM procedure on MGSS if the bolt is missing.

D) Inspect and Tighten the Intermediate Steering Shaft Bolt to Steering Gear to 29 N·m {2.95 kgf·m, 21.4 ft·lbf}. Note this bolt is a "R" part but can be tightened if not torqued to spec. Access to this bolt is located in the engine bay.

NOTE: Rotate the steering wheel until the joint bolt on the steering column side and steering gear side reaches the removal position. See photo and diagram below.
