### **SYMPTOM DESCRIPTION**

The swing gate name plate on about 49 of the above vehicles may not have the correct wording as indicated on the Maroney label. The name plate should indicate "Jeep Beach" instead of "JL".

NOTE: Some vehicles above may have been identified as not involved in this campaign and therefore have been excluded from this campaign.

IMPORTANT: Some of the involved vehicles may be in dealer new vehicle inventory. Dealers should complete this campaign service on these vehicles before retail delivery. Dealers should also perform this repair on vehicles in used vehicle inventory and those vehicles in for service. Involved vehicles can be determined by using the VIP inquiry process

### **REPAIR TO BE PERFORMED**

Inspect the swing gate name plate wording for "**Jeep Beach**" if not present replace the name plate.

### **COMPLETION REPORTING / REIMBURSEMENT**

Claims for vehicles that have been serviced must be submitted on the DealerCONNECT Claim Entry Screen located on the Service tab. Claims paid will be used by FCA to record recall service completions and provide dealer payments. Use the following labor operation numbers and time allowances:

1. Open the swing gate door locate and verify if "Jeep Beach" wording is on the name plate (Figure 1).



2. Does the name plate contain the "Jeep Beach" wording (Figure 1)?

> Yes: No further service required, claim the inspection LOP, return the vehicle to the customer.

- > No: Proceed to step 3.
- 3. Carefully drill out the 4 rivets, remove the name plate and DISCARD.
- 4. Align the **NEW** name plate onto the 4 holes and install a rivet in each hole.
- 5. Return the vehicle to the customer.
