- A whistling noise may be heard from the engine compartment.

Workshop findings:

The following DTCs are stored in the engine control module ECM, J623 (address word 0001):

- DTC P2ADF00 Intake Air System Leak Bank 2 (must be stored).
- DTCs pertaining to misfires on Bank 1 may also be stored.
- DTC P227900 Intake Air System Leak Bank 1 may be stored, if so please also perform service solution in TSB 2069351.

In this case, replace the full load breather line for cylinder bank 2.


- 1. Do not replace the oil separator for bank 1 or bank 2 or the part load breather lines.
