## AV CONTROL UNIT EXCHANGE AND MAP SD CARD REPLACEMENT

### SERVICE INFORMATION

When replacing (exchanging) an AV Control Unit, **Do NOT remove the Map SD Card.** The Map SD Card is matched to the unit.

**HINT:** See Figures 1 and 2 for Map SD Card location.

- If an AV Control Unit is sent to Clarion without the Original Map SD Card, Clarion will NOT accept it. The AV Control Unit will be sent back to the dealer.
- If the dealer does NOT resend the unit to Clarion with the original (matched) Map SD Card within 30 days, the entire AV Control Unit (including SD Card) cost will be charged back to the dealer.
- To order a replacement matched Map SD Card, fill out an order form and fax it to Clarion.

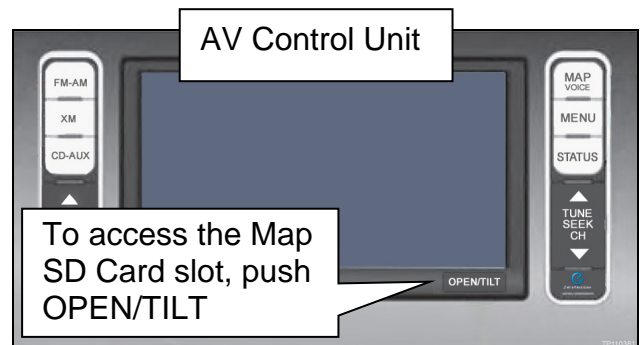

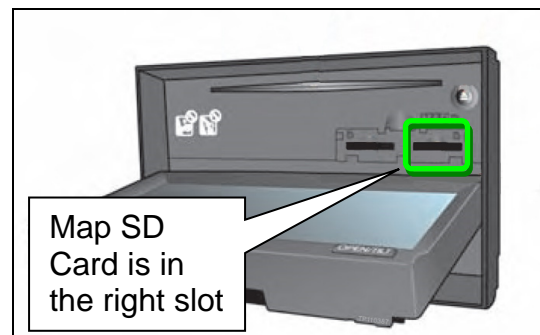
