Symptom/Vehicle Issue: Power Sliding Door Will Not Open And Or Close.

**Customer Complaint/Technician Observation:** Customer complains the power sliding door (PSD) doesn't work with power commands and or will not open or close. Technician may notice the drive cable is damaged and out of position rendering the door inoperable.

**Discussion**: The PSD power drive cable system should be inspected for damage. Cable damage can eventually wear through or catch and extrude itself from the braided cable. Damage to the grooves of the cable tensioner may cause it to not work properly. Refer to Service Library 08 - Electrical / 8N - Power Systems / Power Sliding Door for servicing information.

## Repair tips:

- Disassembly should take place without further door cycles or door movement if possible.
- If further door cycles or movement is required, only open the door enough to gain access to and exposed/visible cable.
- Cut cable to free door. Replace any damaged components.
- Once the exposed/visible cable is cut, only open door enough to gain access to cable tensioner bolt.








- Disengage cable tensioner bolt & assembly from vehicle per procedure in Service Library 08 - Electrical / 8N - Power Systems / Power Sliding Door.
- Do not remove the motor drum cover.








