## **PURPOSE**

To announce a Fast Feedback Program for replacing the Engine Assembly (Sales Code ESJ), Engine Parts, Supercharger Assembly, Fuel System Parts, Engine Wiring and Engine Nameplate in an effort to collect, monitor and correct quality issues in a timely and efficient manner.

### **Models affected:**

• 2023 Dodge Challenger SRT Demon 170 (LA)

#### TIMING:

August 17, 2023 – February 29, 2024

**NOTE**: At the end of this Fast Feedback program, normal Parts Ordering and Service Information procedures will apply.

#### ACTION:

When customer input and technician diagnosis suggest an Engine Assembly, Engine Parts, Supercharger Assembly, Fuel System Parts, Engine Wiring and Engine Nameplate defect, drivability or electronic issue, the dealer must:

- Review the nature of the problem and perform all necessary diagnostics.
- Contact the STAR Center at 1-800-850-7827 and review the details of the problem and the diagnostics.



















**NOTE:** All parts needed for these repairs will be "order restricted" during the term of this program. The STAR Center will determine if replacement is necessary based on the information provided, and if approved, the STAR Center will place the order for the dealer.

- If an Engine Assembly, Engine Parts, Supercharger Assembly, Fuel System Parts, Engine Wiring and Engine Nameplate repair is necessary, you will be advised by STAR of any special instructions regarding component removal and return.
- To avoid damage and fluid spills, all returned parts must be shipped in the same container provided with the new replacement part.

NOTE: DO NOT disassemble the Engine Assembly, Engine Parts, Supercharger Assembly, Fuel System Parts, Engine Wiring and Engine Nameplate without prior approval from STAR. Chargebacks will be imposed for unauthorized internal Engine Assembly, Engine Parts, Supercharger Assembly, Fuel System Parts, Engine Wiring and Engine Nameplate diagnostics.

All Engine Assemblies, Supercharger Assemblies and some Engine parts must be returned using UPS (Heavy) transportation. All Fuel System Parts, Engine Wiring, some Engine Parts and Engine Nameplate must be returned using UPS Ground. A STAR Center representative may initiate the FasTrack process in certain cases to ensure proper component packaging and return. All other parts should follow the normal parts return process.

**DO NOT** return an Engine Assembly, Engine Parts, Supercharger Assembly, Fuel System Parts, Engine Wiring and Engine Nameplate via DDS.

## **ADDITIONAL INFORMATION:**

NOTE: It is possible for a vehicle to have multiple parts on restriction.

Goodwill Alternate Transportation reimbursement requests can be submitted on the same claim as the warranty repair. Refer to Warranty Bulletin D-19-28 (Rev. H) for complete Goodwill Alternate Transportation Guidelines.

Please ensure that all affected dealership personnel are aware of this bulletin.
