#### HEADREST IS UNCOMFORTABLE FOR SOME OCCUPANTS

This Service Information Bulletin (Revision 1) replaces SI B52 08 22 dated November 2022.

### **SITUATION**



The decorative hard plastic piece, centered in the front seat's headrest (circled area), may contact a person's head when they are between 4' 10" and 5' 6" in height.

# **CAUSE**

Design element of the seat.

## CORRECTION

In the case of customer concern, for applicable vehicles produced prior to July 1, 2023, there is a push-in cushion insert available to plug up the square hole in the front seat headrest(s) that provides additional support.

This retrofit procedure can be performed without driving the vehicle into the workshop.

The front seat headrests design was changed starting with July 1, 2023 i20 vehicle production.

## **PROCEDURE**



1. For vehicles produced from Start of Production up to July 1, 2023, there is push-in cushion insert available to plug up the square hole in the headrest. It is inserted from the front of the seat and pulled through from the rear of the seat to lock into position.



2. The insert slides thru the square decorative hard plastic piece centered in the front seat's headrest.



3. When removing, the cushion insert must be pushed out in the direction of travel!
