POOR APPEARANCE DUE TO UNEVEN REAR BELTLINE MOLDING JOINTS (5-DOOR HB ONLY)

2019-2024 Mazda3 5-Door HB (Japan built) vehicles with VINs lower than JM1 BP**** ** 700253 (Produced before Sept. 1, 2023)

DESCRIPTION

Some customers may complain about the poor appearance due to an uneven rear beltline molding joint.



This concern is caused by the rear beltline molding not being manufactured according to the original designed shape. To eliminate this concern, the rear beltline molding manufacturing process was improved to prevent form shape discrepancies from the original design.

Customers having this concern should have their vehicle repaired using the following repair procedure.

REPAIR PROCEDURE

- 1. Verify customer concern.
- 2. Replace the rear beltline molding(s) with a new one(s) according to the instructions on MGSS (REAR BELTLINE MOLDING REMOVAL/INSTALLATION).
- 3. Verify the repair.
