Repair Procedure

1. Does the vehicle exhibit a vibration or shudder sensation from the transmission in Drive and/or Reverse at speeds under 8mph (13kph)?

NOTE

This condition is ONLY present when the internal combustion engine is engaged.

- YES Continue to step 2.
- NO This bulletin does NOT apply. Continue diagnosis using the applicable Repair Manual.
- 2. Is the vehicle equipped with a transmission built prior to the date determined in the Production Change Information section?
 - **YES** Continue to step 3.
 - NO This bulletin does NOT apply. Continue diagnosis using the applicable Repair Manual.
- Replace the transmission assembly kit.
 Refer to TIS, applicable model and model year Repair Manual:
 - 2023 RX 500h: *Drivetrain – Hybrid Transmission/Transaxle –* "PC60 (Hybrid Transmission / Transaxle): Hybrid Vehicle Transaxle: <u>Removal / Installation</u>"
- 4. Using GTS+, check for and clear ANY DTCs.
- 5. Test-drive the vehicle and confirm the condition no longer exists.
