LOUD VIBRATION NOISE WHEN ELECTRIC A/C COMPRESSOR IS OPERATING

BULLETIN NOTES APPLICABLE MODEL(S)/VINS

2024 CX-90 PHEV vehicles with VINS lower then JM3KK*****151673 (produced before November 24, 2023)

DESCRIPTION

Some vehicles may exhibit a loud vibration noise when the electric A/C compressor is operating. Due to processing variation of the counter-balance bushing (a weight to balance eccentric rotation) installed in the electric compressor, some of the bushing strongly interferes with the shaft, resulting in the humming noise. To eliminate this concern, the machining accuracy of the counter-balance bushing has been improved.

Customers having this concern should have their vehicle repaired using the following repair procedure.

REPAIR PROCEDURE

1. Verify the customer concern.

NOTE: Some vibration noise is normal. Compare to another CX-90 PHEV if needed.

2. Replace the electric compressor with new one according to the instructions in MGSS (A/C COMPRESSOR REMOVAL/INSTALLATION [e-SKYACTIV PHEV]).

3. Verify the repair.


