#### **DESCRIPTION**

Some customers may complain that the rear side of the quarter window side molding is loose.



This is caused by the quarter window glass molding deforming due to harmful external conditions such as extreme heat or excessive force applied, and the double-sided tape fixing the molding's back side detaches. To eliminate this concern, the double-sided tape has been widened to enhance attachment.

Customers having this concern should have their vehicle repaired using the following repair procedure.

#### REPAIR PROCEDURE

- 1. Verify the customer concern.
- 2. Replace the quarter window glass with a new one referring to the instructions in MGSS (QUARTER WINDOW GLASS REMOVAL/INSTALLATION).

**NOTE:** When installing the quarter glass, pay attention to where it aligns to the rear door beltline molding and the upper molding above the rear window. More than 2 MM misalignment in the horizontal or vertical directions is visible from 2-3 meters away.



3. Verify the repair.
