Non-Lightning - Equipped With Minor Feature Codes C2BAW And FDDAA - Intermittent Trailer Brake System Fault See Manual Message In The IPC, Inoperative Trailer Brake Controller, And/Or DTCs U0131:87, U0140:87, U0100:87 And/Or U0121:87 Stored In The TRM When Installing The Trailer Brake Contoller Kit

Markets: North American markets only

Issue: Some 2024 F-150 non-Lightning vehicles equipped with minor feature codes C2BAW and FDDAA may exhibit an intermittent **Trailer Brake System Fault See Manual** message in the IPC, inoperative trailer brake controller, and/or DTCs U0131:87, U0140:87, U0100:87 and/or U0121:87 stored in the TRM when installing the trailer brake controller kit ML3Z-19H332-AB. To confirm a vehicle is built with a certain minor feature code, review the build information by double-clicking the VIN in the upper left corner in the PTS. Trailer brake controller kit ML3Z-19H332-AB does not include the correct TRM for 2024 F-150 vehicles, and this kit should not be installed on 2024 F-150 vehicles. To correct this condition, follow the Service Procedure to bring the vehicle to its original state and successfully install the trailer brake controller.

Action: Follow the Service Procedure to correct the condition on vehicles that meet all of the following criteria:

- 2024 F-150 non-Lightning
- equipped with minor feature codes C2BAW and FDDAA
- One of the following symptoms after installing the trailer brake controller kit ML3Z-19H332-AB:
 - Intermittent Trailer Brake System Fault See Manual message in the IPC
 - Inoperative trailer brake controller
 - DTCs U0131:87, U0140:87, U0100:87 and/or U0121:87 stored in the TRM

Claim Quantity refers to the total number of individual pieces required to repair the vehicle.

Package Order Quantity refers to the amount of the service part number package(s) required to repair the vehicle.

Number In Package refers to the number of individual pieces included in a service part number package.

Service Procedure

- **1.** Reinstall the <u>TRM</u> originally installed onto the vehicle from the factory. Refer to the <u>WSM</u>, Section 417-01 Exterior Lighting, Removal and Installation.
- 2. Run the IPC Towbar Configuration application using the latest software level of the FDRS scan tool.
- 3. Run the TRM Towbar Configuration application using the latest software level of the FDRS.
- **4.** To successfully install the trailer brake controller onto the vehicle, use the <u>TRM</u> service part number RL3Z-19H332-A (not the <u>TRM</u> that came with trailer brake controller kit ML3Z-19H332-AB) and follow instruction sheet SKML3J-19H332-AB for installation. To access the instruction sheet on <u>PTS</u>, refer to Workshop > Accessories > Installation > Electrical > (2021-CMY) F150 Trailer Brake Control with Factory IV Hitch. Use the trailer brake switch (ML3Z-14529-AC) that came with the trailer brake controller kit ML3Z-19H332-AB to continue the installation.
