DISCUSSION:

NOTE: This is an “Information Only” Technical Service Bulletin (TSB) to inform dealers of this Warranty Extension.

This Warranty Extension covers the costs of all parts and labor, including diagnosis of any illuminated OBD Malfunction Indicator Lamp (MIL), needed to repair the items listed below for all eligible vehicles that complete Emissions Recalls VB6 or 67A.

Recall VB6 - MY 2019 RAM DJ and D2 Covered Components

Exhaust and Aftertreatment Components Including:

- Diesel Oxidation Catalyst/Diesel Particulate Filter (DOC/DPF) assemblies.
- Selective Catalyst Reduction (SCR) Catalyst Assembly.
- Ammonia Oxidation Catalyst.
- NOx Sensors (including Engine Out and System Out).
- DPF Differential Pressure Sensor.

Diesel Exhaust Fluid (DEF) System:

- DEF Injector.
- DEF Injector Controller
- DEF Storage Tank.
- DEF Delivery Lines.
- DEF Quality Sensor.
- DEF Supply Module, Pump and Temperature Sensor Unit.

Exhaust Gas Recirculation (EGR) System Including:

- EGR Cooler.
- EGR Valve.
- EGR Temperature Sensors.

- EGR Cooler Bypass Valve and Actuator.

Recall 67A – MYs 2013 - 2018 RAM DJ and D2 Covered Components

Exhaust and Aftertreatment Components Including:

- Selective Catalyst Reduction (SCR) Catalyst Assembly.
- Ammonia Oxidation Catalyst.
- NOx Sensors (including Engine Out and System Out).

Diesel Exhaust Fluid (DEF) System:

- DEF Injector.

- DEF Quality Sensor.

POLICY:

This Warranty Extension coverage period is the greater of: (i) 10 years from the date of initial sale or 193,121 km (120,000 mi) on the odometer (whichever comes first); or (ii) 4 years or 77,248 km (48,000 mi) from date of Emissions Recall VB6 or 67A completion (whichever comes first), but not to exceed December 31, 2033 for any vehicle that receives the recall after April 09, 2027. See Warranty Bulletin: U.S. D-24-10 for details associated with the Warranty Extension.

NOTE: For vehicles covered under this warranty extension, use the standard warranty LOPs.
