Dear Mazda Dealer Partners,

On June 3, 2024 we requested the SSPC5/4621B MDRT Tool be returned to our vendor. Thank you to all dealers who have already returned their MDRT tool. As of today, we have received 392 tools back.

ACTION REQUIRED SSPC5/4621B MDRT Tool Return:

Please return the tool to our vendor below. If the tool is not returned to the vendor address below, by July 15, 2024 your Mazda dealer will be charged \$1,000 to the parts statement. Your District Service Manager will be updated on a bi-weekly basis on the status of the returned tools.

SHIP ONLY THIS ONE TOOL TO THE VENDOR ADDRESS BELOW, DO NOT SHIP TO ANY OTHER ADDRESS. PLEASE SAVE YOUR UPS OR FEDEX TRACK #. For any questions regarding this return, please contact Dealer Recall Help on [OneMazda](#).

SHIPPING REIMBURSEMENT: For all dealers who returned a tool, the Mazda Recall team will be reimbursing each Mazda Dealer \$15 for shipping expenses. This credit will be listed on the July parts statement or if returned after July, will be on the August parts statement. For any questions regarding credits, please reach out to Dealer Recall Help on [OneMazda](#) and attach the actual UPS or FedEx Ground invoice (not an estimate). NOTE: Overnight or express charges for shipments will not be reimbursed.
