Symptom/Vehicle Issue: Backup Camera Poor Image Quality Inspection

Discussion: When the vehicle is placed in reverse, the backup image is shown on the screen. Customers may complain that they see a poor/blurry/dark image on the screen.

Diagnosis: Clean off the lens of the camera with a soft cloth to clear any debris. Print out the 8.5x11 eye chart located on the last page of this document. Place the eye chart about 1 foot away from the rear bumper of the vehicle. Compare the image of the eye chart with the test images. If the camera image does not appear more derogated than the test images, the camera is functioning as expected.

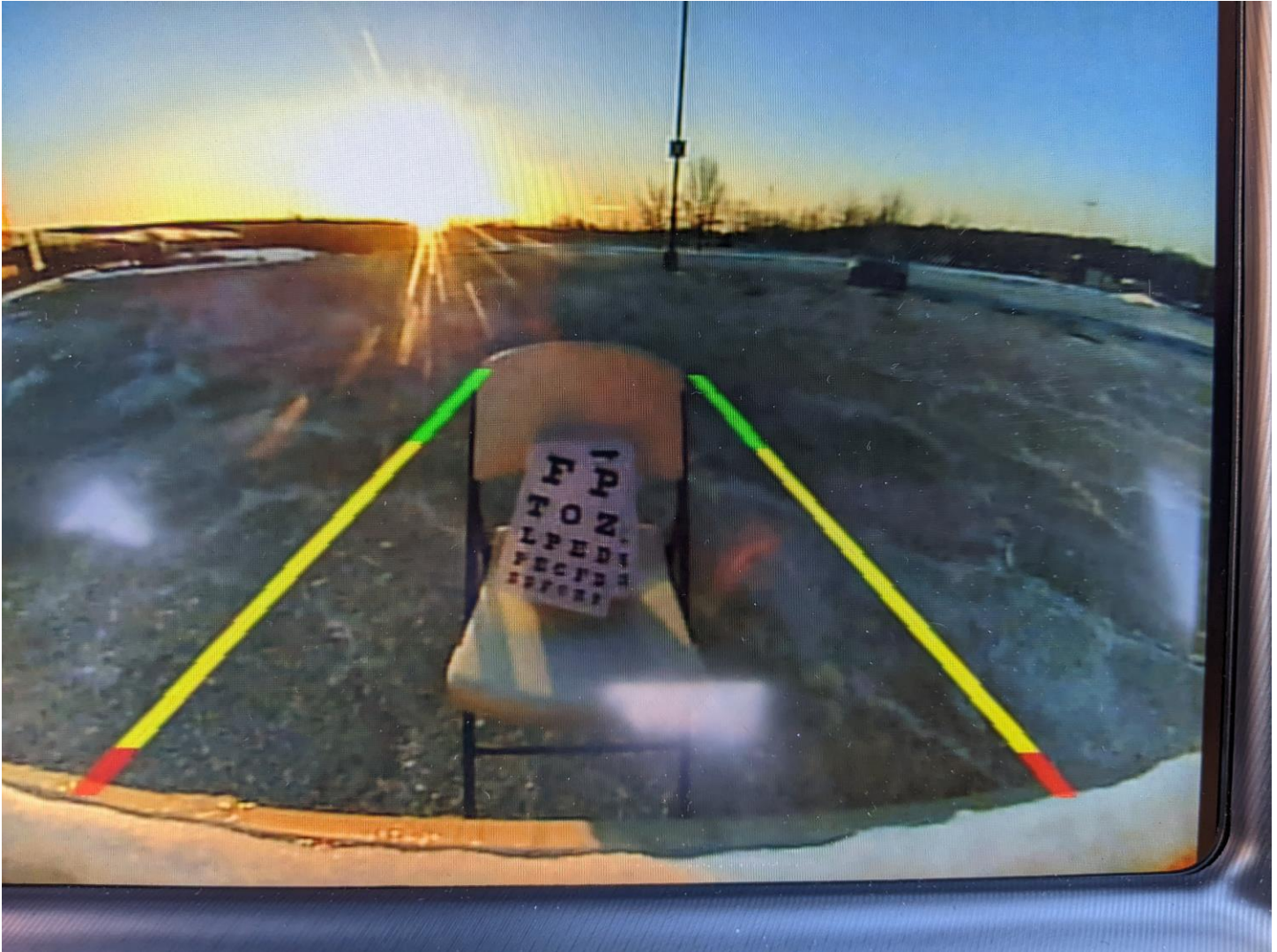
Images located on the following pages are of an optimal camera image in different ambient lighting conditions. It is normal for the letters on the lower lines to be blurry.

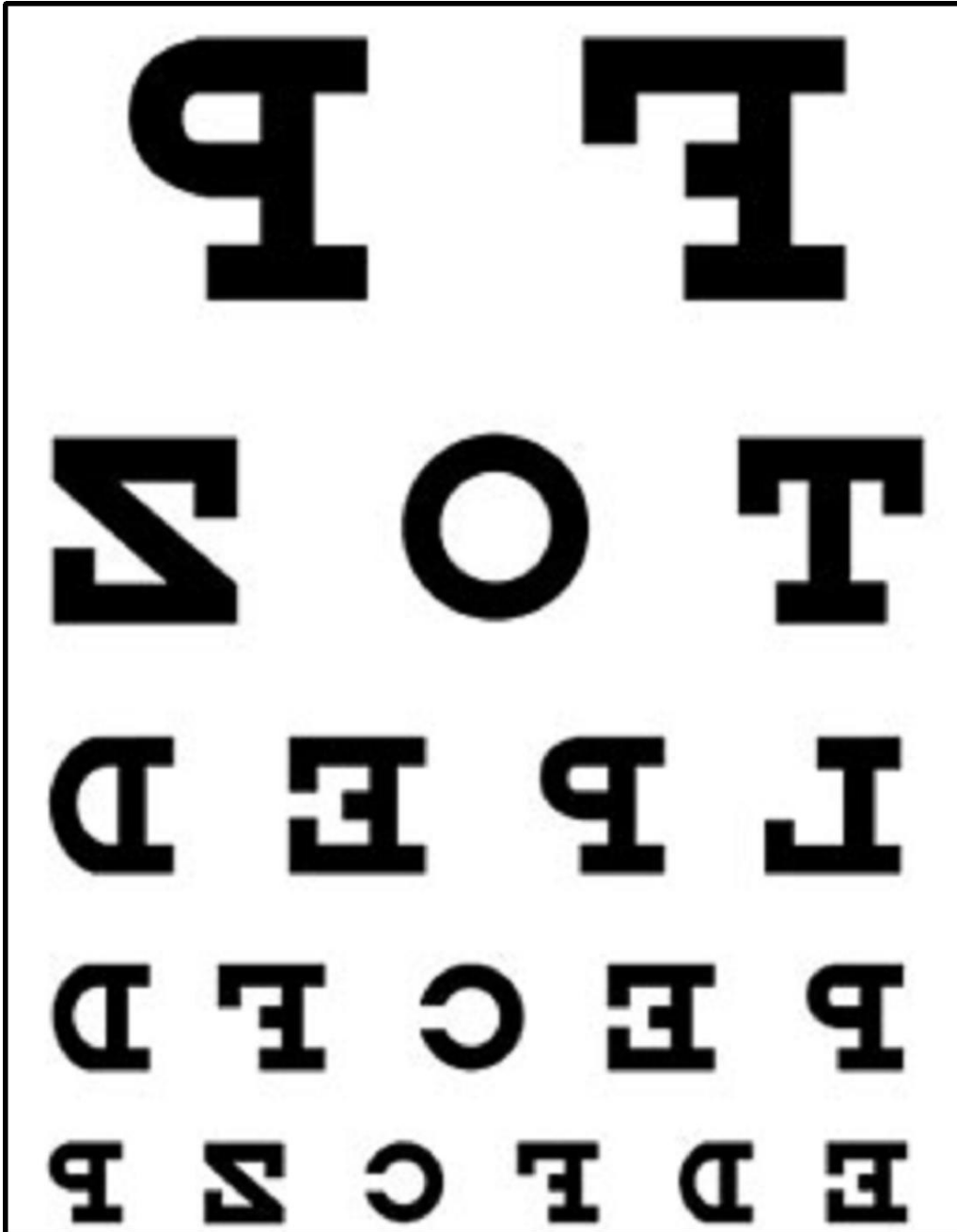
