SITUATION

A Check Control message (CCM) displays for "Transmission oil service required" (ID 2120).

This warning will trigger based on the following that applies:

- From 60,000 miles (~95,000 km) to 78,000 miles (~125,000 km), or
- After six (6) years: The "six years" time interval is determined the production date of the vehicle. It is not based on the day/date of the first registration, or the completion date of the pre-delivery check (PDI).

If the vehicle is driven more than approx. 1900 miles (~3,000 km) after the first CCM, then a second message will be display for "Transmission fault!" (ID 368).

CAUSE

The oil in the double clutch transmission ages with increasing usage, as well as depending on the vehicle's driving profile.

When the transmission oil reaches the end of its service life, a regular "transmission oil change in the double clutch transmission" is required.

CORRECTION

Change the oil in the DKG.

PROCEDURE

Follow Repair Instruction 00 11 276 Oil change in the double-clutch transmission (DKG)
