Certain 2019 – 2023 model year Genesis G70 vehicles may have a Fuel Control Valve (FCV) in the High-Pressure Fuel Pump (HPFP) assemblies that could allow excess fuel to enter the fuel pump. This condition may result in a reduction or loss of motive power at low speeds. The vehicle will also have Diagnostic Trouble Code (DTC) P0088.

At Genesis, we are committed to providing vehicles of outstanding quality and value. In an effort to meet this commitment, Genesis is extending the warranty coverage for the HPFP under this condition to 15 years or 150,000 miles from the date of original retail delivery or date of first use and is valid for original and subsequent owners.

Our records indicate that your vehicle, with the VIN listed above, is covered by this warranty extension.

WHAT SHOULD YOU DO?
