Emissions Recall 7325C - Hybrid System Warning Light May Turn On affecting 2024-2025 CX-90 and 2025 CX-70 vehicles

CONDITION OF CONCERN

On certain subject vehicles, during normal driving, a temporary decrease in insulation resistance may be detected, which could be mistakenly judged as an electric leakage, causing the hybrid system warning light to turn on and the leakage detection message to be displayed. The DTC POAA6:00 may be stored in memory. In such a condition, if the vehicle is once stopped and the vehicle power is switched off, it may become impossible to restart the vehicle due to fail-safe mode activation.

- P0AA6:00 - High voltage insulation malfunction: Decrease in vehicle insulation resistance

Causal factor: Inappropriate software of PCM

REPAIR OUTLINE: Reprogram the PCM with the Mazda Modular Diagnostic System (M-MDS), using Mazda Diagnostic And Repair Software (MDARS).

Note: ECM and/or TCM may be automatically reprogrammed together during the PCM software update to correlate with the modified PCM software. TCM initial learning is required if the TCM is reprogrammed.


