To inform California dealers about the new California Air Resources Board (CARB) approvals for select 128CI and 131CI Stage IV Kits.

### Vehicles Affected

2017-2022: Milwaukee-Eight powered CVO, Touring, and Softail vehicles

### Markets Affected

California only.

### Summary

CARB has approved select 128CI and 131CI Stage IV kits to be sold under Executive Order K-007-14 for select 2017- 2022 Harley-Davidson CVO, Touring, and Softail vehicles. See table below for necessary details. Installation of these products outside the specified fitment statements will result in a non-compliant vehicle and possible fines.

At this time, select calibrations exist on the latest **California Pro Street Tuner only (Part No. 41001166A) for 2021-2022 fitment calibrations ONLY**.

All 2017-2020 Stage IV calibrations for the below hardware are **not** available.

All 2021-2022 128CI Stage IV calibrations and 2021-2022 131CI Twin-Cooled Stage IV calibrations for the below hardware are **NOW** available.

This bulletin will be updated when each set of calibrations become available.

Important Notes:

- These products are **mandatory dealership installation only**.
- These products are Vehicle Identification Number (VIN) restricted. Dealerships must provide VIN information from the vehicle which the kit will be installed upon. If warranty coverage still exists on the vehicle, the VIN should also be entered through the Custom Coverage program.
