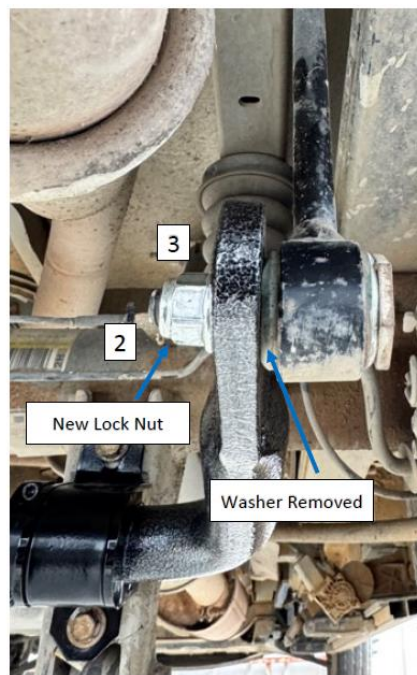
FIELD FIX INSTRUCTIONS REAR STABILIZER BAR END LINK

PLEASE READ THIS INSTRUCTION SHEET COMPLETELY BEFORE STARTING YOUR INSTALLATION



INSTALLATION NOTES

- 1) BEFORE STARTING YOUR INSTALLATION, BE SURE TO SET PARKING BRAKE AND CHOCK TIRES.
 - 2) TO EASE INSTALLATION AND TO PROPERLY ADJUST THE BAR, THE WEIGHT OF THE VEHICLE MUST BE ON THE SUSPENSION, AS IF DRIVING DOWN THE ROAD. DO NOT RAISE VEHICLE BY THE FRAME
1. Remove the Locking Nut (#2) and washer from the lower end of the end link attached to the rear sway bar. Discard the washer and lock nut on the vehicle.
 2. Open the Hellwig resupply lock nut kit. Install the new lock nut onto the end link and tighten down each side to the factory end link rod.
 3. Use a torque wrench to torque down the locking nuts to 90ft lbs.
